What is a Hate Crime?

Hate crimes are those violations of law committed against individuals or property based upon a belief or perception regarding their race, color, national origin, ancestry, gender, religion, religious practice, age, disability or sexual orientation, regardless of whether the belief or perception is correct. These crimes may include acts of physical assault, assaults with weapons, harassment, vandalism, robbery, rape, verbal harassment, attacks on homes or places of worship, forms of vandalism, and murder. It occurs everywhere: in schools, the workplace, public places and in the home.

Effect on Victims

Hate crime may have particularly damaging effects on its victims, their families and the communities of which they are a part. A sense of anger is one of the common responses to being the victim of a hate crime, but so is a deep sense of personal hurt and betrayal. Victims experience feelings of powerlessness, isolation, sadness and suspicion. Fear is another pervasive victim response. Victims fear for their own safety and for their family's safety. Most report changes in their lifestyle such as where they walk, how they answer the phone, reactions to strangers, suspicion of co-workers, and other such changes. Fear can take on varying qualities and can drastically disrupt the lives of some victims.

How the Hate Crime Victim Advocacy Program Can Help

Victims of violent crimes can experience mental, physical and emotional trauma that can have a life long devastating impact. Support provided by the Crime Victims Center can help minimize the impact crime has on victims by providing information which enables them to make informed decisions with knowledge of their rights and providing the services they are entitled to. Strict confidentiality is maintained and immigration status never questioned.

What Multilingual Services Are Available?

- Assistance in filing for New York State crime victims compensation claims for reimbursement of expenses which relate to personal injury, death and loss of personal property.
- Criminal Justice Advocacy including courtroom accompaniment.
- Multi-agency service referrals for:
 - Individual and group counseling.
 - Legal and medical information.
 - Assistance with preparation of the victim impact statement and VINE registration.
 - Educational advocacy for minors.
 - Advocacy, information and referrals for concrete services, housing, long-term medical services, employment referrals, child support enforcement and social services assistance.
 - U Visa Application for victims of certain crimes.

What Expenses Related To The Crime May Be Reimbursed?

Innocent victims of violent crime (and certain victims of property crimes), certain relatives, dependents and guardians of the victim can apply for out-of-pocket expenses not covered by insurance or other resources. The New York State Office of Victim Services (OVS) offers reimbursement related to personal injury, death and loss of essential personal property which is related to criminal activity.

The specific expenses OVS may cover include:

- Medical and counseling expenses
- Loss of essential personal property (up to \$500. including \$100. for cash)
- Lost wages or lost support (to \$30,000.)
- Transportation (court/medical)
- Occupational/vocational rehabilitation
- Crime scene clean-up (up to \$2,500.)
Good Samaritan property losses (to \$5000.)
- Essential personal property expenses (ie. eyeglasses, medication, clothing)
- Burial or Funeral Expenses
- Emergency Awards may also be granted
